



## 2015 EHF Club Manager blended learning programme

Initiated by the EHF CAN in cooperation with the EHF Professional Handball Board (PHB) the programme will consist of 2 modules:

The 1<sup>st</sup> module - planned from 1 April to 15 May (Option 1 prior to the Seminar) or as an alternative from 1 June to 31 July (Option 2 after the Seminar) - will be organized as an e-learning module\*\*) including "online testing" in 2 parts and a best practice assignment. This e-learning module focuses on EHF European Cup Regulations, EHF European Championship Qualification Regulations, EHF Event Management in general as well as Media Management and Social Media in particular. Module 1 is also accessible for participants of the 2012, 2013 and 2014 EHF Club manager Seminar (on request)!

The 2<sup>nd</sup> module will be the 2015 EHF Club Manager Seminar held in Cologne / GER on the occasion of the VELUX EHF FINAL 4 as in the previous years, focusing on key-notes, best practices and discussions. Module 2 from 28 – 30 May 2015 will be the time to meet personally and exchange experience and knowledge. Key note speeches will be held by presenters experienced in the field "Media Management and Social Media". Furthermore you will be asked to present your "Best Practice". Details on the programme and presenters will be published early in May 2015.
